Funding a Clinical Safety Study: Our organization provided grants in total of \$310,000 to the University of Texas Southwestern Medical Center to fund their FDA-approved safety study for ION283, a drug with the potential to treat patients with Lafora Disease. Our efforts ensured that enough funds were available to enroll all 10 patients in the study.

Family Support Services: Our staff and interns receive compensation in order to provide families with a variety of support resources. In 2025, we hosted 16 committee meetings to plan outreach, financing, and family support projects, sent 14 newsletter communications, produced 2 publications and 5 research simplifications, surveyed priorities of over 60 families through our caregiver registry, connected more than 30 families through regular family support meetings, and hosted 15 virtual workshops to identify biomarkers and clinical best practices for treating Lafora. Our organization also maintains software and website subscriptions to disseminate these resources.

Annual Lafora Science Symposium: Our organization hosts an annual science symposium that brings together families, scientists, clinicians, patient advocates, and industry representatives to accelerate the development of therapies for Lafora disease.
